Annual Obligations Report

BACKGROUND

Regulatory and Agreement Language

According to Federal regulations, 23 CFR Part 450.334:

- a) *In metropolitan planning areas, on an annual basis, no later than 90 calendar days following the end of the program year, the State, public transportation operator(s), and the MPO shall cooperatively develop a listing of projects (including investments in pedestrian walkways and bicycle transportation facilities) for which funds under 23 U.S.C. or 49 U.S.C. Chapter 53 were obligated in the preceding program year.*
- b) *The listing shall be prepared in accordance with §450.314(a) and shall include all federally funded projects authorized or revised to increase obligations in the preceding program year, and shall at a minimum include the TIP information under §450.326(g)(1) and (4) and identify, for each project, the amount of Federal funds requested in the TIP, the Federal funding that was obligated during the preceding year, and the Federal funding remaining and available for subsequent years.*
- c) *The listing shall be published or otherwise made available in accordance with the MPO's public participation criteria for the TIP.*

The **Metropolitan Planning Agreement for the Hampton Roads Area**, entered into as of September 13, 2018, references the AOR and identifies the role of each agency including the state and public transportation providers in the metropolitan planning process. Definitions

Program Year – The year for which project obligations are reported – in the case of the Annual Obligation Report, the program year is the Federal fiscal year. The 2025 Annual Obligation Report covers the Federal fiscal year from October 1, 2024 to September 30, 2025.

Obligation – An obligation is a legal commitment by the Federal government to pay the Federal share of a project's cost. An obligated project is one that has been authorized by the Federal agency and for which funds have been committed. Projects for which funds have been obligated are not necessarily initiated or completed during the program year, and the amount of the obligation will not necessarily equal the total cost of the project. For projects under the auspices of the Federal Transit Administration (FTA), obligation occurs when the FTA grant is awarded. For projects under the auspices of the Federal Highway Administration (FHWA), obligation occurs when a project agreement is executed and the State/grantee requests that the funds be obligated.

Released – An obligation removed from a project, usually as the result of a decrease in the cost estimate, a project awarded for a lesser amount than originally authorized at advertisement, or a FHWA Financial Integrity Review and Evaluation (FIRE) project level review.

HRTPO STAFF REVIEW OF FY 2025 ANNUAL OBLIGATION REPORT (AOR) INPUT

HRTPO staff received the Virginia Department of Rail and Public Transportation (DRPT) portion of the AOR on November 12, 2025. HRTPO staff reviewed the information submitted by DRPT and found no issues.

HRTPO staff received the Virginia Department of Transportation (VDOT) portion of the AOR on October 23, 2025. HRTPO staff compared AOR line items against project data in the FY 2024-2027 HRTPO Transportation Improvement Program (TIP), noted any discrepancies, and completed a review of the submitted data.

The HRTPO Staff Review was forwarded to VDOT on December 30, 2025, for review/comment (staff email to VDOT and DRPT is posted in the appendices of this report). HRTPO staff posted the Annual Obligation Report (AOR) on the HRTPO website using the information provided by DRPT and VDOT at the time of posting on December 30, 2025.

HRTPO staff will follow up and continue to work with VDOT to address the issues identified below from their AOR review.

Since the AOR is developed on an annual basis, the most up-to-date project information continues to be available in the HRTPO Transportation Improvement Program (TIP), which can be accessed at <https://www.hrtpotip.org/>

Summary of Issues Reported by HRTPO Staff Following AOR Review

1. AOR data lists one project where the HRTPO TIP planned obligation does not match the AOR planned obligation nor the AOR actual obligation. UPC 121110 (BOAT MUP WARWICK, ELMHURST, & YORKTOWN) has an HRTPO TIP FY 2025 STP/STBG planned obligation of \$459,200; whereas the AOR FY 2025 STP/STBG planned obligation is \$139,200 and the AOR FY2025 STP/STBG actual obligation is \$69,600.
2. AOR data lists one project, UPC 111787 (ROUTE 17 WIDENING), which shows actual obligations on it but does not have AOR planned obligations or HRTPO planned obligations in FY 2025.
3. AOR data has discrepancies in planned obligations compared to obligation amounts listed in the HRTPO TIP.
4. AOR data listed a project as having planned and actual obligations on it but is not in the HRTPO FY 2024-2027 TIP. UPC 117118 (SANDBRIDGE ROAD SIDEWALK) has AOR data for an FY 2025 STP/STBG planned obligation of \$43,200 and an FY 2025 STP/STBG actual obligation of \$81,600.

1. AOR data lists one project where the HRTPO TIP planned obligation does not match the AOR planned obligation nor the AOR actual obligation. UPC 121110 (BOAT MUP WARWICK, ELMHURST, & YORKTOWN) has an HRTPO TIP FY 2025 STP/STBG planned obligation of \$459,200; whereas the AOR FY 2025 STP/STBG planned obligation is \$139,200 and the AOR FY2025 STP/STBG actual obligation is \$69,600.
2. AOR data lists one project, UPC 111787 (ROUTE 17 WIDENING), which shows actual obligations on it but does not have AOR planned obligations or HRTPO planned obligations in FY 2025.
3. AOR data has discrepancies in planned obligations compared to obligation amounts listed in the HRTPO TIP.
4. AOR data listed a project as having planned and actual obligations on it but is not in the HRTPO FY 2024-2027 TIP. UPC 117118 (SANDBRIDGE ROAD SIDEWALK) has AOR data for an FY 2025 STP/STBG planned obligation of \$43,200 and an FY 2025 STP/STBG actual obligation of \$81,600.
