Work Activity This Period:

Execute Engagement Plan

Evaluating study segments on construction complexity, permitting challenges and project readiness

- Applying evaluation metrics on I-664 mandated segment first to validate process and effectiveness
- Other mandated segments will be tested in the March timeframe


