Update allocation as follows: receive FY 2024 CMAQ allocation of \$122,390, plus \$30,598 CMAQ match, from the HRTPO CMAQ Reserve Account.
11/16/2023	Amendment to UPC 102867, Hampton Traffic Signal System Retiming, to partially redo the original FY 2021-2024 TIP Amendment approved by the HRTPO Board at its April 20, 2023 meeting, and to re-transfer a total of \$260,311 CMAQ funds from this completed project to UPC 109410. VDOT did not complete the original April 20, 2023 transfer to UPC 109410 as questions arose after the amendment was approved by the HRTPO Board. Since the FY 2024-2027 TIP became effective October 1, 2023, the transfer can be completed as a re-transfer rather than a reversal of the same amount of funds from the same completed project. The April 20, 2023 TIP Amendment also had a transfer of an FY 2002 LOM allocation of \$65,077 to UPC 109410. Per VDOT, this allocation did not exist on this project, and therefore, the LOM was not transferred to UPC 109410. The CMAQ funds from UPC 102867 are pre-2005. The HRTPO tracks all FY Previous CMAQ and RSTP funds and although VDOT has consolidated all FY Previous funds before FY 2005 into FY 2005, the HRTPO must use the actual fiscal years in order to maintain the integrity of the HRTPO CMAQ/RSTP Tracking Tables. VDOT and HRTPO staff have agreed that the HRTPO Tracking Tables will be the acknowledged source for determining the fiscal years of any transfer of such pre-2005 CMAQ funds. Update allocations as follows: transfer FY 2002 CMAQ Federal only allocation of \$260,311 to UPC 109410.
11/16/2023	Amendment UPC 102991, Bridge Road Traffic Signal Upgrades, to reverse the original FY 2021-2024 TIP Amendment approved by the HRTPO Board at its April 20, 2023 meeting and to transfer a total of \$25,738 in CMAQ funds from the HRTPO CMAQ Reserve Account. Per VDOT, the funds were to be directly transferred from four CMAQ projects in financial closeout to the recipient CMAQ project. However, VDOT CO transferred surplus CMAQ funds to the HRTPO CMAQ Reserve Account to facilitate project closeout based on the Appropriation Act which required transfer action by May 1, 2023. The local matches are also affected and will be addressed in this amendment. This amendment includes the transfer of \$9,962 in CMAQ matching funds from one FY to another for UPC 100607 as the FY 2006 project funds are currently aligned with the June 20, 2013 HRTPO Board-approved action letter and the HRTPO CMAQ Tracking Table. The funds will be transferred to FY 2007 in order for VDOT to close out UPC 100607. Per VDOT, the funds were to be directly transferred from two CMAQ projects in financial closeout to the recipient CMAQ project. However, VDOT CO transferred surplus CMAQ funds to the HRTPO CMAQ Reserve Account to facilitate project closeout based on the Appropriation Act which required transfer action by May 1, 2023. There is a local match that is also addressed. Per the HRTPO CMAQ Tracking Table, there is only \$13,371 in FY 2005 for UPC 97717. VDOT did not complete the original April 20, 2023 transfer from UPC 102867 as questions arose after the amendment was approved by the HRTPO Board. Since the FY 2024-2027 TIP became effective October 1, 2023, the transfer can be completed as a re-transfer rather than a reversal of the same amount of funds from the same completed project. The April 20, 2023 TIP Amendment also had a transfer of an FY 2022 LOM allocation of \$65,077 from UPC 102867. Per VDOT, this allocation did not exist on UPC 102867 and therefore, the LOM allocation will be revised as an addition, rather than a transfer, by the City of Hampton. Although the original FY 2021-2024 TIP Amendment revised the cost estimate, the FY 2024-2027 TIP, effective October 1, 2023 included this revision. The schedule change will be addressed in this amendment. The CMAQ funds from UPC 102867 are pre-2005. The HRTPO tracks all FY Previous CMAQ and RSTP funds, and although VDOT has consolidated all FY Previous funds before FY 2005 into FY 2005, the HRTPO must use the actual fiscal years in order to maintain the integrity of the HRTPO CMAQ/RSTP Tracking Tables. VDOT and HRTPO staff have agreed that the HRTPO Tracking Tables will be the</p>

	acknowledged source for determining the fiscal years of any transfer of such pre-2005 CMAQ funds. The April 20, 2023 TIP Amendment for UPC 109410 received funds for UPC 113752.
