The Virginia Department of Transportation (VDOT) requests a TIP Amendment from the Hampton Roads Transportation Planning Organization (HRTPO) to add UPC 123041, #SMART24 Battlefield Blvd & I-64 Ramp Improvements Walmart, to the FY 2024-27 TIP.
