The Virginia Department of Transportation (VDOT) requests a TIP Amendment from the Hampton Roads Transportation Planning Organization (HRTPO) to add UPC 123173, #SMART24 West Queen Street Corridor Improvements, in the FY 2024-27 TIP. The project proposes to improve bike and pedestrian connections on W. Queen St in the City of Hampton by adding a 10' shared use path and missing sidewalk segments. The work will take place within the existing right of way, utilizing a road diet. The existing 4-lane undivided facility will be reduced to 2-lanes, with the existing north side lanes being converted to a 10' shared use path. The proposed roadway configuration results in one lane in each direction. The 10' shared use path will be located on the north side of W. Queen St. Sidewalks will be introduced on the south side of Queen St from St. Johns Drive to Power Plant Parkway. Additional segments of sidewalk will be added in missing sections. On the western terminus of Queen St, the shared use path will transition to a 5' sidewalk from Weaver Rd to Power Plant Parkway. Project also includes mill and overlay, restriping of pavement markings and connections to the Power Plant Parkway Sidewalk project. Fiscal constraint of the project is demonstrated outside of the current TIP years, but within the FY 2025-2030 SYIP. To that end, we request UPC 123173 be added to the FY 2024-27 TIP including the following information:

The Virginia Department of Transportation (VDOT) requests a TIP Amendment from the Hampton Roads Transportation Planning Organization (HRTPO) to add the Construction Phase, and revise the cost estimate, schedule, allocations, and obligations for UPC T22709.
