**1. Chesapeake – FY 2024-2027 TIP Amendment  
UPC 127093 – I-64/I-464 Interchange – Phase A**

Attached is a request from the Virginia Department of Transportation (VDOT) to amend the Hampton Roads FY 2024-2027 Transportation Improvement Program (TIP) to add UPC 127093, a Chesapeake project.

Currently, the upcoming FY 2026-2031 Six-Year Improvement Program (SYIP) is locked down until July 1, 2025; therefore, the allocations and any obligations will be added to a handout and distributed at the July 2, 2025 TTAC meeting. A new public notice will also be posted to the HRTPO website on July 2, 2025.

The specifics of the request are described below:

- **UPC 127093 – I-64/I-464 Interchange – Phase A**
  - Add project to TIP.
  - Description: Construct a 3 three-lane section added capacity, splitting into two lanes merging into the I-64 WB Mainline and one lane into the Collector Distributer (CD) WB lanes. The CD lanes shift east of I-64/I-464 interchange, braiding under the two-lane bridge. I-464 NB will get added capacity for lane balance.

The Virginia Department of Transportation (VDOT) requests a TIP Amendment from the Hampton Roads Transportation Planning Organization (HRTPO) to add UPC 123160, #SMART24 J. The Virginia Department of Transportation (VDOT) requests a TIP Amendment from the Hampton Roads Transportation Planning Organization (HRTPO) to modify the cost estimate, schedule, and obligations for UPC 120649, Route 17 (Bridge Road) Roadway Widening, in the FY 2024-27 TIP. This project will make improvements along Bridge Road (Route 17) from Windward Lane to Harbor View Boulevard, including road widening from two to three lanes. In addition, the project will replace two traffic signals. Additional pedestrian and bike accommodations will also be extended on the east side of Route 17 to close the gap between Harborview Boulevard and Breezeport Way.
