This document – part of the compendium of reports that comprise the 2045 Hampton Roads Long-Range Transportation Plan (LRTP) – includes the unfunded prioritized candidate projects evaluated as part of the LRTP process that are not included in the fiscally constrained 2045 LRTP. These unfunded projects warrant future consideration for inclusion in an amended 2045 LRTP should additional funding be identified.

OVERVIEW

The Hampton Roads Transportation Planning Organization (HRTPO) develops a fiscally constrained Long-Range Transportation Plan (LRTP) to help guide multimodal transportation investments that promote system efficiency while maximizing the use of scarce transportation funds. For the past five years, the HRTPO has been collaborating with regional stakeholders, including the public, to update the region's LRTP to the horizon year of 2045.

As part of the LRTP planning process, approximately 260 candidate projects were evaluated with the **Regional Scenario Planning Framework** and updated **HRTPO Project Prioritization Tool**. Due to fiscal constraint requirements and limited financial resources, not all candidate transportation projects evaluated with the HRTPO Project Prioritization Tool could be incorporated into the 2045 LRTP. Of the candidate projects submitted by regional stakeholders and concerned citizens, 137 of these projects were included in the fiscally constrained LRTP. The remaining candidate projects become part of the **Hampton Roads Regional Transportation Vision Plan**, an illustrative and unconstrained list of prioritized transportation projects. These projects are **unfunded investments** (totaling about \$60 Billion). Should additional funding be identified for the region (not already accounted for as part of the fiscal constraint process), unfunded projects from this regional vision plan can be considered by the HRTPO Board as amendments to the 2045 LRTP.

This report, the ninth in a series of reports outlining the development of the 2045 LRTP, lists the unfunded prioritized candidate projects that comprise the Regional Transportation Vision Plan.


Previous 2045 LRTP reports focus on:

Hampton Roads 2045 Long-Range Transportation Plan: DRAFT Plan Performance, Regional Transportation Vision Plan, and Public Involvement Documentation Reports

As the federally designated Metropolitan Planning Organization for Hampton Roads, the HRTPO is required to develop and maintain the region's Long-Range Transportation Plan (LRTP). The HRTPO is currently updating the LRTP to a horizon year of 2045. The plan serves as the transportation blueprint, identifying all regionally significant projects over the next 24-years. The development of the 2045 LRTP for the past five years has been based on a collaborative process involving many regional stakeholders and the public to identify, prioritize, and fiscally constrain needed transportation investments. Based on analysis using the [Regional Scenario Planning Framework](#) and the [HRTPO Project Prioritization Tool](#), the 2045 LRTP identifies \$17 Billion to maintain the existing transportation system and an additional \$13.7 Billion for multimodal projects and studies that will help improve the movement of people and goods.

As part of Federal requirements, a [Regional Conformity Assessment](#) (RCA) on the 2045 LRTP and 2021-2024 Transportation Improvement Program was completed and submitted to the Federal Highway Administration for review. A joint FHWA/FTA finding of conformity was received on May 19, 2021.
