The Elbow Road Phase II-B and Elbow Road Phase II-D projects are both active RSTP projects. The overall Elbow Road Extended Phase II parent project was split into three (3) phases via an approved TIP Amendment in January, 2018. The subject \$9M in FY24 RSTP funds were always earmarked for the Elbow Road Phase II-D project and align with the Phase II-D schedule. The FY24 RSTP funds were originally allocated to the overall Elbow Road Phase II parent project (now known as Elbow Road Phase II-B) as a placeholder until the parent project could be successfully split into phases. The requested FY24 RSTP funding transfer completes the process of phasing the overall Elbow Road Phase II parent project and aligns the funding with the project schedules for each phase.

Current cost estimates, allocations, obligations, expenditures, and funds available for transfer associated with the Elbow Road Extended Phase II-B and II-D projects have been confirmed by VDOT. We request that the Transportation Technical Advisory Committee (TTAC) and the Transportation Planning Organization (TPO) consider this TIP amendment request at the January, 2019 meetings.
