

D. FY 2018-2021 TIP Amendment Request: UPC 111021

Attached is a request from the Virginia Department of Transportation (VDOT) to amend the FY 2018-2021 Transportation Improvement Program (TIP) to add one project in Norfolk as described below:

- **UPC 111021 – Granby Street Bike Lanes**

- Add project to TIP
- Description: Installation of new bike lanes on a 2-mile stretch of Granby Street.
- Project Length: 2.0 miles
- Cost Estimate as follows:
 - Preliminary Engineering (PE): \$108,000
 - Right of Way (RW): \$0
 - Construction (CN): \$714,000
 - Total Cost Estimate: \$822,000
- Schedule as follows:
 - PE Phase: Start: 8/17/2020; End: 10/20/2022
 - RW Phase: N/A
 - CN Phase: Start: 10/20/2022; End: 10/3/2024
- Allocations
 - Add FY 2021 National Highway Performance Program (NHPP) allocation of \$86,400, plus \$21,600 match
- Obligations
 - Add FY 2020 PE Phase National Highway System/National Highway Performance Program (NHS/NHPP) obligation of \$108,000

This project is considered exempt from conformity under the following provision contained in section 93.126 of the conformity rule, Table 2 Exempt Projects under “Other”, as the project is a bicycle and pedestrian facility project.

This request is being made available for public review and comment from February 26, 2020 through March 11, 2020.

Mr. Eric Stringfield, VDOT Hampton Roads District Transportation Planning Director, will be available to answer questions on this item.


