

AGENDA ITEM #11: FY 2018-2021 TIP AMENDMENT REQUEST: 115512

Attached is a request from the Virginia Department of Transportation (VDOT) to amend the FY 2018-2021 Transportation Improvement Program (TIP) to add one project as described below:

- 115512 – Longhill Road Shared Use Path in James City County
 - Add project to TIP
 - Description: Construction of a shared use path to fill gaps on Longhill Road from DePue Drive to Lane Place.
 - Cost Estimate as follows:
 - Preliminary Engineering (PE): \$530,000
 - Right of Way (RW): \$270,000
 - Construction (CN): \$3,600,000
 - Total Cost Estimate: \$4,400,000
 - Schedule as follows:
 - PE Start: 12/2/2019; End: 2/15/2023
 - RW Start: 2/15/2023; End: 2/13/2024
 - CN Start: 2/13/2024; End: 12/16/2024
 - Allocations
 - Add FY 2018 High Priority Projects (HPP) Program allocation of \$94,920
 - Add FY 2019 District Grants Program (DGP) allocation of \$100,000
 - Add FY 2021 DGP allocation of \$335,080
 - Obligations
 - Add FY 2020 PE Phase Advanced Construction (AC) Other obligation of \$530,000

This project is considered exempt from conformity under the following provision contained in section 40 CFR 93.126 of the conformity rule: *Air Quality – Bicycle and Pedestrian Facilities*, and therefore does not require a conformity determination.

This request is being made available for public review and comment from September 25, 2019 through October 9, 2019.

Mr. Eric Stringfield, VDOT Hampton Roads District Transportation Planning Director, will brief the TTAC on this item.

The Virginia Department of Transportation (VDOT) requests a TIP Amendment from the Hampton Roads Transportation Planning Organization (HRTPO) to add project UPC 115512 – Longhill Road Shared Use Path in James City County to the FY 2018-2021 TIP. This project is construction of a shared use path to fill gaps on Longhill Road from DePue Drive to Lane Place. Work includes adding a median, on-road bike lanes, and shared-use path. To that end we request UPC 115512 be added including the following information to the FY 2018-21 TIP:

 - Add Estimate \$ 4,400,000


