

#### D. 2021 CMAQ/RSTP PROJECT SELECTION PROCESS: RECOMMENDED PROJECTS AND ALLOCATIONS

The Transportation Technical Advisory Committee met on November 3, 2021 to consider a set of recommended projects to receive allocations of FY 2028 Congestion Mitigation and Air Quality Improvement Program (CMAQ) funds and Regional Surface Transportation Program (RSTP) funds. Since the total “penciled-in” requests for FY 2028 in both funding programs were near or above the projected available funding targets, the Transportation Programming Subcommittee (TPS) had previously recommended that new applications for CMAQ and RSTP projects not be accepted this year.

The TPS recommended allocating available FY 2028 CMAQ and RSTP funds to previously-approved projects with “penciled-in” requests. Furthermore, the TPS recommended allocating FY 2028 CMAQ funds to existing CMAQ projects with recent funding reductions due to adjustments in the Fixing America's Surface Transportation (FAST) Act.
