1. Call to Order

2. Public Comment Period

3. Submitted Public Comments

4. Approval of Agenda

Chair Lewis asked LRTP members for any objections to the agenda as written. Hearing none, Ms. Carolyn Murphy Moved to approve the agenda as written; seconded by Mr. Troy Eisenberger. The Motion Carried via Affirmation.

5. Approval of June 3, 2020 Minutes

Chair Lewis reported that the LRTP Summary Minutes from the June 3, 2020 meeting were included in the July 1, 2020 LRTP Subcommittee Agenda. Chair Lewis asked for any additions or corrections to the Minutes. Hearing none, Mr. Tim Cross Moved to approve the Minutes as written; seconded by Ms. Murphy. The Motion Carried via Affirmation.

6. 2045 LRTP: Regional Priority Project Selection Guidelines

Ms. Dale Stith briefed the LRTP Subcommittee on this agenda item, summarizing the Regional Priority Project (RPP) Guidelines that were established as part of the identification of the “Round 1” RPPs currently in the 2040 LRTP and as part of the analysis of a pipeline of “Round 2” candidate RPPs. As part of this item, supporting HRTPO resolutions related to the RPPs were summarized, along with HRTPO staff recommendations for updating the RPP Guidelines for the 2045 LRTP based on this information.

Following a group discussion, the recommendation for the 2045 LRTP Regional Priority Projects Selection Guidelines are as follows:

- Include Committed Regional Priority Projects from the 2040 LRTP (per HRTPO Resolution 2018-03, RPPs not considered Committed will be re-evaluated for the 2045 LRTP)
- Be consistent with HB2313 Legislation (provide the greatest congestion relief for the greatest number of citizens in Hampton Roads)
- Consider HRTPO Board Resolution 2020-04 (I-64 Regional Express Lanes being a component of RPPs, based on project readiness)
- Meet Regional Project Cost Threshold of \$100 Million

7. 2045 LRTP: Guiding Principles for Fiscal-Constraint/Project Selection

Ms. Stith briefed the LRTP Subcommittee on this agenda item, providing a background of fiscal constraint terminology and requirements, summarizing the Fiscal Constraint Guiding Principles from the 2040 LRTP, and discussing data to help establish Guiding Principles for the 2045 LRTP.

After significant group discussion, the LRTP subcommittee recommended the following Guiding Principles for Fiscal-Constraint for the 2045 LRTP:

- Maintenance Needs
 - Set aside funding to cover projected maintenance needs for the 2020-2045 planning horizon
 - Includes State of Good Repair
- Committed Projects
 - Projects under construction or soon to be constructed and fully-funded in the Six-Year Improvement Program are automatically included in the LRTP (reflect balance to complete)
- “Grouped” Projects
 - Set aside funding to cover “Grouped” Projects (projects not individually listed in the LRTP since not considered “regionally significant”)
 - 10% set aside of anticipated 2045 LRTP ‘Construction Funding’ estimate (may be revisited when forecast is available)

- Regional Funds
 - HRTF reserved for Regional Priority Projects (RPPs)
 - Funding Plan for RPPs to be developed by HRTAC and will be included in the fiscally-constrained 2045 LRTP
- Distribution of Funding Assumptions
 - Reserve SMART SCALE High-Priority Funding Program to fiscally-constrain RPPs
 - Highway/Transit Funding Split based on historical CMAQ and RSTP funding
 - CMAQ 60/40 (with flexibility to modify to 50/50)
 - RSTP 70/30
 - Transportation Alternatives Set-Aside reserved for Active Transportation projects
- Project Prioritization
 - Projects within funding categories selected based on overall Project Prioritization score

Mr. Bryan Stilley Moved to approve the 2045 LRTP Guiding Principles for Fiscal Constraint including the recommended changes from the group discussion; seconded by Mr. Jackson.
